BE IT REMEMBERED, that on this day the undersigned authority, acting under and by virtue of the provisions of Article IV, Section 7 of the Constitution and Section 574 of the Election Code, does hereby officially announce and declare the results of the election held throughout the State "YES" and "NO" for the following proposed amendments to the Constitution of the State of Louisiana, on Saturday, November 13, 2021, as per returns filed in this office by the various Parish Boards of Election Supervisors as follows:

BE IT KNOWN, that I, John Bel Edwards, Governor of the State of Louisiana, acting by virtue of the provisions of Article XIII, Section 1 of the Constitution of the State of Louisiana, do hereby officially announce and declare the results of the election held throughout the State "YES" and "NO" for the following proposed amendments to the Constitution of the State of Louisiana, on Saturday, the 13th day of November, 2021, in accordance with the Constitution and laws of this State, as per returns filed in the office of the Secretary of State by the various Boards of Election Supervisors throughout the State, to-wit:

(Adds Article VII, Section 3.1)	Do you support an amendment to lower the maximum allowable rate of individual income tax and to authorize the legislature to provide by law for a deduction for federal income taxes paid?
